The Sweepstakes Period is subject to fifteen (15) monthly entry periods (each, an "Entry Period" or "Month"). For each Entry Period, one (1) first prize winner ("First Prize Winner") and one (1) second prize winner ("Second Prize Winner") will be selected at random as outlined in the "WINNING/NOTIFICATION" section herein (each, a "Monthly Drawing"). In order to receive the grand prize ("Grand Prize"), Grand Prize Winner must (among other conditions provided herein); (a) provide proof of being a private pilot via a private pilot certificate; (b) provide proof of at least fifty (50) hours of total fight time; (c) provide written sign off by a certified flight instructor with no less than

twenty (20) hours of instruction in the specific airplane chosen; and (d), if choosing the ICON, a seaplane rating (see "PRIZES" section for complete Grand Prize details) (collectively, the "Grand Prize Conditions"). Grand Prize Conditions must be completed within twelve (12) months from the date for which the Grand Prize Winner is confirmed. The Entrants who are selected as the First Prize Winners and Grand Prize Winner must also have a unique, personal and valid social security number for Sponsor (defined below) to report the tax liability associated with acceptance of the respective Prize. Entrants who enter via the AMOE (marked "Bonus Entry") during the Sweepstakes Period will earn one (1) Bonus Entry into the Monthly Drawing associated with the Entry Period for which his/her envelope was marked "Bonus Entry", postmarked and received. Entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. Sponsor will not verify receipt of entries for Entries. All entries submitted by mail become the sole property of the Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, or damaged mailed entries. Entrants may submit a maximum of one (1) individual envelope to enter the Sweepstakes via the AMOE.

WINNING/NOTIFICATION: There are two (2) ways to win prizes in this Sweepstakes:

- 1. **Monthly Drawings**: There will be fifteen (15) Monthly Drawings held for this Sweepstakes on or about the dates listed in the "DATES OF SWEEPSTAKES/ENTRY PERIOD" section. For each monthly drawing, one (1) First Prize Winner and one (1) Second Prize Winner will be selected at random from among all eligible entries received within the Entry Period (and any non-winning eligible entries received from previous Entry Periods). Each First Prize Winner will receive a first prize ("First Prize") and each Second Prize Winner will receive a second prize ("Second Prize") as further described below. Non-winning eligible entries from previous Entry Periods will be eligible for subsequent Monthly Drawings.  - a. Notification: The Grand Prize Winner will be notified by the Independent Administrator via email within approximately three (3) business days from the Grand Prize drawing date. Grand Prize Winner must complete and return "Required Documents' as outlined in the "PRIZE CLAIMS" section below.

Each of the drawings will be conducted by the Independent Administrator whose decisions are based upon their sole discretion and interpretation of these Official Rules and are final and binding in all respects.

Potential Prize Winner must report income to the IRS. In the event it is deemed during the verification process that the potential Prize Winner does not have a unique, personal and valid social security number for Sponsor to report the tax liability associated with acceptance of the Prize, such potential Prize Winner will be disqualified, and an alternate will be notified as outlined above. Valid social security numbers will be determined by IRS requirements. If it is determined by the Sponsor, in its sole discretion, that a potential Prize Winner is not eligible or otherwise not in compliance with these Official Rules, the potential Prize Winner forfeits his/her right to the Prize and an alternate will be notified as outlined in the "WINNING/NOTIFICATION" section above, even if the disqualified potential Prize Winner's name may have been publicly announced. In the event that a potential Prize Winner is disqualified for any reason, Sponsor/Independent Administrator shall have no liability or obligation to such individual. Sponsor will make three (3) attempts to determine prize winners for this Sweepstakes via alternate winner selection (if applicable) after which, any unclaimed prizes will go unawarded.

PRIZES: The total approximate retail value ("ARV") of all prizes available to be won in this Sweepstakes is: \$302,500 broken down as follows:

- 1. **Grand Prize:** One (1) Grand Prize will be awarded in this Sweepstakes, inclusive of Grand prize Winner's choice of one (1) of the following:
 - a. **Option 1:** One (1) used ICON A5 airplane (with less than five hundred (500) hours), having an ARV of (\$250,000) and \$30,000 cash, awarded in the form of a check, which can be used towards insurance, training and/or retrieval of the aircraft. The total ARV of the Option 1 Grand Prize is \$280,000.
 - b. **Option 2:** One (1) used Tecnam Astore LSA airplane (with less than three hundred (300) hours), having an ARV of (\$250,000) and \$30,000 cash, awarded in the form of a check, which can be used towards insurance, training and/or retrieval of the aircraft. The total ARV of the Option 2 Grand Prize is \$280,000.
 - c. **Option 3**: In lieu of an airplane, Grand Prize Winner may opt for \$100,000 cash awarded in the form of a check. The ARV of the Option 3 Grand Prize is \$100,000.

Option 1 & Option 2 prize details:

Grand Prize Conditions: If Option 1 or Option 2 is chosen, Grand Prize Winner must (a) provide proof of being a private pilot via a private pilot certificate; (b) provide proof of at least fifty (50) hours of total fight time; (c) provide written sign off by a certified flight instructor demonstrating proficiency of instruction in the specific airplane type chosen; and (d), if choosing the ICON, a seaplane rating. Proof of an insurance policy, underwritten specifically for the aircraft chosen, must also be provided prior to delivery. The aforementioned must be provided within twelve (12) months of receipt of the Required Documents as outlined in the PRIZE CLAIMS section herein. If the Grand Prize Winner is unable to complete the flight training or cannot obtain the required insurance, Grand Prize Winner will be provided with the Option 3 Grand Prize.

In accepting the Option 1 or Option 2 Grand Prize, Grand Prize Winner understands and agrees that, notwithstanding the extent of the experience and skill of the pilot, operating an aircraft is an inherently dangerous activity that may result in permanent injury, dismemberment or even death. By way of illustration only, hazards include inclement weather, equipment failure and myriad unanticipated exigencies during flight, take-off or landing. To the fullest extent permitted by law, Grand Prize Winner assumes all such risks.

Without limiting any other release contained herein and to the fullest extent permitted by law, Grand Prize Winner releases, indemnifies and agrees to hold harmless Sponsor and Independent Administrator from any and all liability for any injury, death or property damage arising (directly or indirectly, in whole or in part) from ownership and/or operation of the aircraft. The preceding includes not only any injury or loss suffered by the Grand Prize Winner him/her/themselves but also by any third party, including passenger(s) on the aircraft.

In awarding the Option 1 or Option 2 Grand Prize to Grand Prize Winner, Sponsor and Independent Administrator are directly relying on Grand Prize Winner's representation that he/she/they is a licensed pilot who is certified to operate the aircraft awarded as the Grand Prize as of the date the aircraft is awarded.

In accepting the Option 1 or Option 2 Grand Prize, Grand Prize Winner further understands and agrees that (a) he/she/they will assume full responsibility for the proper maintenance of the aircraft and (b) Sponsor and Independent Administrator have not obtained any insurance for the benefit of Grand prize Winner, his/her/their heirs, executors, administrators or anyone who may take by or through the Grand Prize Winner with regard to Grand Prize Winner's acceptance and use of the Option 1 or Option 2 Grand Prize.

Aircraft Details: If accepting the aircraft, Grand Prize winner agrees to adhere to all FAA regulations and standards prescribed in the pilot operating handbook and owner's manual of the aircraft during the time

of ownership and accepts all liability while operating the aircraft. Aircraft will undergo an inspection with an authorized A&P that is familiar with the aircraft prior to delivery. Aircraft color, options and accessories to be determined at the sole discretion of the Sponsor. All upgrades shall be completed at Grand Prize Winner's sole cost. Grand Prize Winner must have and provide a valid pilot license and provide proof of existing, applicable Aircraft Insurance Coverage prior to delivery of aircraft. Grand Prize Winner is required to comply with all applicable federal, state and local laws, rules and regulations, including but not limited to licensing and insurance requirements and FAA regulations required to maintain a private pilot certification. Unless otherwise stated herein, the sales tax, title and licensing of the aircraft is the sole responsibility of the Grand Prize Winner. Grand Prize Winner will be solely responsible for any applicable registration, and insurance fees and any other expenses not listed herein related to receipt, possession, acceptance and use of the Grand Prize. Delivery: Sponsor shall not be responsible for delays in availability of the aircraft, and final awarding of the aircraft is subject to availability. Sponsor however, shall use all reasonable efforts, subject to availability, to award the aircraft within ninety (90) days after the Grand Prize Winner completes the Grand Prize Conditions. The Grand Prize Winner must personally retrieve the aircraft within thirty (30) days of written notification of delivery and must present adequate personal identification and evidence of legally required insurance and other Grand Prize Conditions, or the Grand Prize will be forfeited without compensation of any kind, and an alternate Grand Prize Winner may be randomly selected from among all remaining non-winning eligible entries received as outlined in the "WINNING/NOTIFICATION" section above.

The aircraft will be delivered solely with the express written limited warranties set forth in the aircraft's applicable Owner's Guide, which warranties shall run for the term set forth in said guide. Grand prize Winner acknowledges that neither Sponsor nor the Independent Administrator nor the Sweepstakes Entities have made nor is in any manner responsible or liable for any warranty, representation or guarantee, expressed or implied, in fact or in law, relative to the Grand Prize described herein, including, but not limited to, its quality, merchantability, mechanical condition or fitness for use. All warranties for the Grand Prize are hereby disclaimed by Sponsor and the Grand Prize Winner will accept the Grand Prize "as is." Grand prize Winner is solely responsible for all applicable taxes (including, without limitation, sales tax and income tax), insurance costs, surcharges, registration, title, license fees, storage, and any other costs incurred in claiming, registering or using the aircraft.

The depiction of the Grand Prize aircraft in any advertising or promotional materials or physical display may not be or reflect the actual aircraft awarded and delivered to the Grand Prize Winner. Any difference between the stated ARV of the Grand Prize and the actual value of the Grand Prize at the time for which it is awarded will not be awarded. The Grand Prize is taxable as income and Grand Prize Winner is solely responsible for any taxes on the Grand Prize, including, but not limited to all applicable federal, state and local taxes.

2. Monthly Prizes

- a. First Prizes: One (1) First Prize will be awarded for each Monthly Drawing. The ARV of each First Prize is \$1,000. A total of fifteen (15) First Prizes will be awarded in the Sweepstakes. The total ARV of all First Prizes to be awarded is \$15,000.
